The minutes from the April 7, 2015 meeting were unanimously approved.

1.) STAFF REPORTS

Ms. Margheritis stated Mr. Romo is currently travelling on business. She stated the Sherman Way Tunnel lighting project has been pushed to July 19, 2015. The work will be done during night time hours, 9:00 p.m. – 4:30 a.m. The project will be halted from November 16, 2015 – January 3, 2016, to minimize any traffic impacts during the holidays and will resume shortly after. The work will be completed by April 2016. Signs will be posted at the entrances of the tunnel at least seven days prior to the work starting.

Mr. Sanders stated the Beautification and Boots on the Ground Working Groups will be suspended for the moment and can be activated when necessary.

Mr. Sanders shared the passing of Harry Berg, President of the VNY Prop Association and former CAC member. There will be a Memorial is his honor on June 13, 2015 at the Airtel Plaza Hotel from 1:00 p.m. to 4:00 p.m. Please notify the family if you are planning to attend.

Mr. Sanders recognized Mr. Khorsand for being featured in the Daily News for promoting and sharing the value of Women in Leadership.

Ms. Sanchez stated Customs (CBP) service at VNY began on May 21, 2015 and there have been over a dozen successful clearances since it began. There will be a Grand Opening Ceremony on August 13, 2015 and formal invites will be sent out. The working hours for the CBP facility at VNY are Thursday to Monday from 12:00 p.m. to 8:00 p.m.

Mr. Kenny LaSalle, Representative from Congressman Tony Cardenas' Office, stated the short-term benefits of the CBP facility at VNY will create jobs at VNY and the long-term benefit is it could open more opportunities for job development in the district. The manufacturing businesses in Van Nuys will benefit because the commute will be shorter than clearing Customs at LAX and this in turn could give companies more incentive to build out within this community and district.

Ms. Natalie Arazi, member of the public and 1st Vice President of the Lake Balboa Neighborhood Council and Chair of the Lake Balboa Neighborhood Council Airport Noise Ad-Hoc Committee discussed the delay in LAWA's response to noise complaints. She stated she made a complaint in January 2015 and still has not received a response. She observed that LAWA is nine months behind in responding to noise complaints and other airports in the area respond within 24 hours.

A. Ad Hoc Committee Report on Early Turns – Discussion/Action

Mr. Schultz stated they will need to hold another Ad Hoc Committee Meeting regarding the Early Turns issue. He handed out a map that was discussed at the May 26th Ad Hoc Committee Meeting. (Attached) This map points out one of the recommendations this Ad Hoc Committee has come up with. Mr. Romo and Ms. Margheritis have already contacted seven out of ten flight schools at VNY and reminded them what the flight patterns are supposed to be.

Mr. Schultz introduced a DRAFT motion as follows:

Whereas, the Van Nuys Airport Citizen's Advisory Council (CAC) has heard testimony from a number of Lake Balboa residents complaining about "Early Turns" creating "New Noise Impacts" emanating from propeller aircraft departing VNY to the south, and,

Whereas, these said noise complaints to the CAC began in the month of November, 2013, and continued on a monthly basis to this date, and,

Whereas, an Ad Hoc Committee was created by the Chairman of the CAC to investigate the "Early Turns" issue and report back to the CAC with recommendations, if any, and,

It is hereby resolved that the CAC moves to adopt the recommendations of the Ad Hoc Committee and urges the Los Angeles Board of Airport Commissioners (BOAC) and Federal Aviation Administration (FAA) to implement these recommendations as soon as possible.

Mr. Schultz stated this pending motion will be brought back to the CAC at the July 7, 2015 Meeting. He stated the Ad Hoc Committee consists of community members, CAC members, a flight school President and pilot, Congressional Office Representative, and a Council Office Representative. He stated Commissioner Telles will be introducing a Resolution to the BOAC at the June 18, 2015 Meeting. He is not aware how it will read at this time.

Ms. Margheritis shared a new graphic regarding this issue with a basic message for all pilots to not turn before the flood basin. This final graphic will be posted on the VNY webpage and hard copies will be delivered to FBO's and flight schools at VNY. This program will have its own thumbnail on the

VNY webpage with one-click access to the program. She stated of the seven out of ten flight schools she and Mr. Romo have met with, all of them are aware of the No Early Turn procedure and advise their students and instructors to abide by it.

Mr. Jason Price, member of the public and President of Mach 1 at VNY stated the Airport Facilities Directory (AFD) is put out by the FAA and prior to a flight all pilots are required to check the information regarding the airport they are going to and adding the language regarding No Early Turns to this document will be very helpful.

Mr. Rankell asked Ms. Margheritis if the tri-fold Pilot's Guide will be also be updated with this No Early Turn notice.

Ms. Margheritis stated they are going to hold off on updating the Pilot's Guide until the Ad-Hoc Committee approves recommended changes to the guide.

Mr. Rankell, Mr. Williams, Mr. Schultz, Mr. Oeland, Mr. Sanders and Mr. Price further discussed this issue.

Mr. Craig Welzbacher, member of the public, thanked the CAC for putting together the Ad Hoc Committee and also thanked LAWA and others for moving this issue forward.

7.) EMERGENCY ITEMS SINCE POSTING OF AGENDA – Discussion/Action No items were discussed.

8.) ADVISORY COUNCIL MEMBERS' COMMENTS - NON-AGENDA ITEMS

Mr. Khorsand thanked Mr. Sanders for the acknowledgement.

Mr. Oeland thanked Ms. Levitan for helping to have the tumbleweed on Roscoe cleared.

Ms. Saunders thanked VNY for their support of the YMCA Breakfast and all those who have helped to push the noise issue forward.

- Mr. Rankell stated he is concerned about the comments regarding VNY's response time to noise complaints.
