

**VAN NUYS AIRPORT CITIZENS ADVISORY COUNCIL
TUESDAY, MAY 1, 2018**

A meeting of the Van Nuys Airport Citizens Advisory Council (CAC) was called to order at 7:06 p.m. by David Rankell. Members present: David Rankell, Ron Merkin, Mel Roberts, Gerald Silver, Kathy Delle Donne, Cindy Goodfellow, Araz Parseghian, Wendy Saunders

The minutes from the April 3, 2018 meeting were unanimously approved.

1.) STAFF REPORTS

Ms. Margheritis addressed the council as it relates to the VNY statistics: She reported 21,103 aircraft operations in March 2018 and this shows an 8.83% increase in operations compared to March 2017. Year-to-date operations are up 18.43% as compared to 2017.

Ms. Margheritis discussed the AAAE Conference she and Mr. Christian Moreno attended in April. Ms. Margheritis informed the council that after discussion with other airport representatives at the conference she found operational numbers are up at all surrounding airports.

Ms. Margheritis addressed the council as it relates to the demolition at Jet Aviation. Despite some environmental challenges this project appears to be on track.

Ms. Margheritis addressed the council as it relates to the construction at the Prop Park. This project is a few months behind schedule and should be completed in the early part of 2019.

Ms. Margheritis stated there are no security updates at this time.

Ms. Margheritis informed the council there are no major VNY items going to the Board at this time. Ms. Margheritis stated the council will be notified of any major VNY items pertaining to leases or other items.

Ms. Sanchez gave an update as it relates to Aviation Career Day which took place last week. Ms. Sanchez thanked Ms. Goodfellow and Mr. Moreno for being part of the panel.

Ms. Sanchez announced the promotion and transfer of Mr. Brandon Nunn to LAX.

Ms. Sanchez notified the council that on May 18, 2018 The Greater San Fernando Valley Chamber of Commerce will be honoring the Van Nuys Airport for their 90th Anniversary, and Aerolease will be honored for their 40th Anniversary. Ms. Sanchez stated the Van Nuys Airport 90th Anniversary Celebration will be postponed for a later date. Ms. Sanchez also notified council of the \$5 Pancake Breakfast fundraiser for the YMCA on Saturday, June 2, 2018. In addition, Ms. Sanchez stated the Frequent Flyers Event will take place at the end of June.

Ms. Margheritis notified the council of her upcoming vacation and absence for the June 4, 2018 CAC meeting. Ms. Sanchez and Mr. Moreno will attend in her absence.

Mr. Merkin commented on the public speaker's issue stating it is disturbing. He also stated he has heard the helicopter/aircraft noise she is speaking about and believes the cause is the waypoints, which he hopes will change. He suggested Ms. Aslan present the medical documentation she mentioned in her comment.

Mr. Rankell apologized to Ms. Sanchez for not being able to attend the Aviation Career Day event.

Mr. Rankell suggested when a council member or member of the public has a noise complaint they should be referred to the Van Nuys Airport Noise office to submit an official noise complaint.

Mr. Silver opposed adjournment.
