## **Temporary Flight Restrictions at VNY Airport for VIP Movement**

THE FAA RECOMMENDS THAT ALL AIRCRAFT OPERATORS CHECK NOTAMS FREQUENTLY FOR POSSIBLE CHANGES TO THIS TFR PRIOR TO OPERATIONS WITHIN THIS REGION. ### **Based on the last information that Airport Operations has received from TSA, see below:**

**12/8/23** – VIP TFR begins on Dec. 08, 2023 at 1615 PST.

**VNY Airport** has been designated a Gateway Airport for TSA screening during this TFR.

AIRCRAFT OPERATORS MUST REGISTER WITH THE TSA FOR GATEWAY SCREENING NO LESS THAN 24 HOURS PRIOR TO THEIR SCHEDULED DEPARTURE TIME. RESERVATIONS FOR SCREENING MAY BEGIN ON 12/07/2023 AND LAST THROUGH THE DURATION OF THE EVENT BY CALLING TSA AT **310-242-2940**.

PILOTS, CREW AND PASSENGERS MUST PROVIDE VALID GOVERNMENT-ISSUED PHOTO IDENTIFICATION TO THE TSA AT THE GATEWAY AIRPORT. GATEWAY SCREENING WILL INCLUDE ID VERIFICATION AND VETTING OF ALL PILOTS, CREW AND PASSENGERS, SCREENING OF PERSONS AND BAGGAGE, AND INSPECTION OF THE AIRCRAFT. NO FIREARMS ON BOARD AIRCRAFT WILL BE AUTHORIZED. NO GIFT WRAPPED PACKAGES.

#### **12/8/23 -TSA SCREENING WILL NOT BE AVAILABLE ON FRIDAY, 12/08/2023.**

- No departures will be authorized from VNY from 1615 PST on Dec. 08, 2023 through 0800 PST on Dec. 09, 2023.
- 

**12/9/23** 0800-1700 PST - TSA screening will be available at **Jet Aviation** only. (see phone number above for TSA reservation).

- **Departures from VNY may ONLY operate during this time.** (0800-1700 PST after TSA clearance)
- 

**12/9/23** from 1700 PST through 12/10/23 at 0800 PST

- No departures will be authorized from VNY.
- 

**12/10/23** 0800-1130 PST - TSA screening will be available at **Jet Aviation** only. (see phone number above for TSA reservation).

- **Departures from VNY may ONLY operate during this time.** (0800-1130 PST after TSA clearance)
- 

**12/10/23** VIP TFR is scheduled to end at 1345 PST.

All arriving flights to VNY will need to obtain clearance through the designated arrival gateways: SJO or PSP. These flights will need reservations throughout the duration of the event by calling TSA reservations using the phone number listed above.
